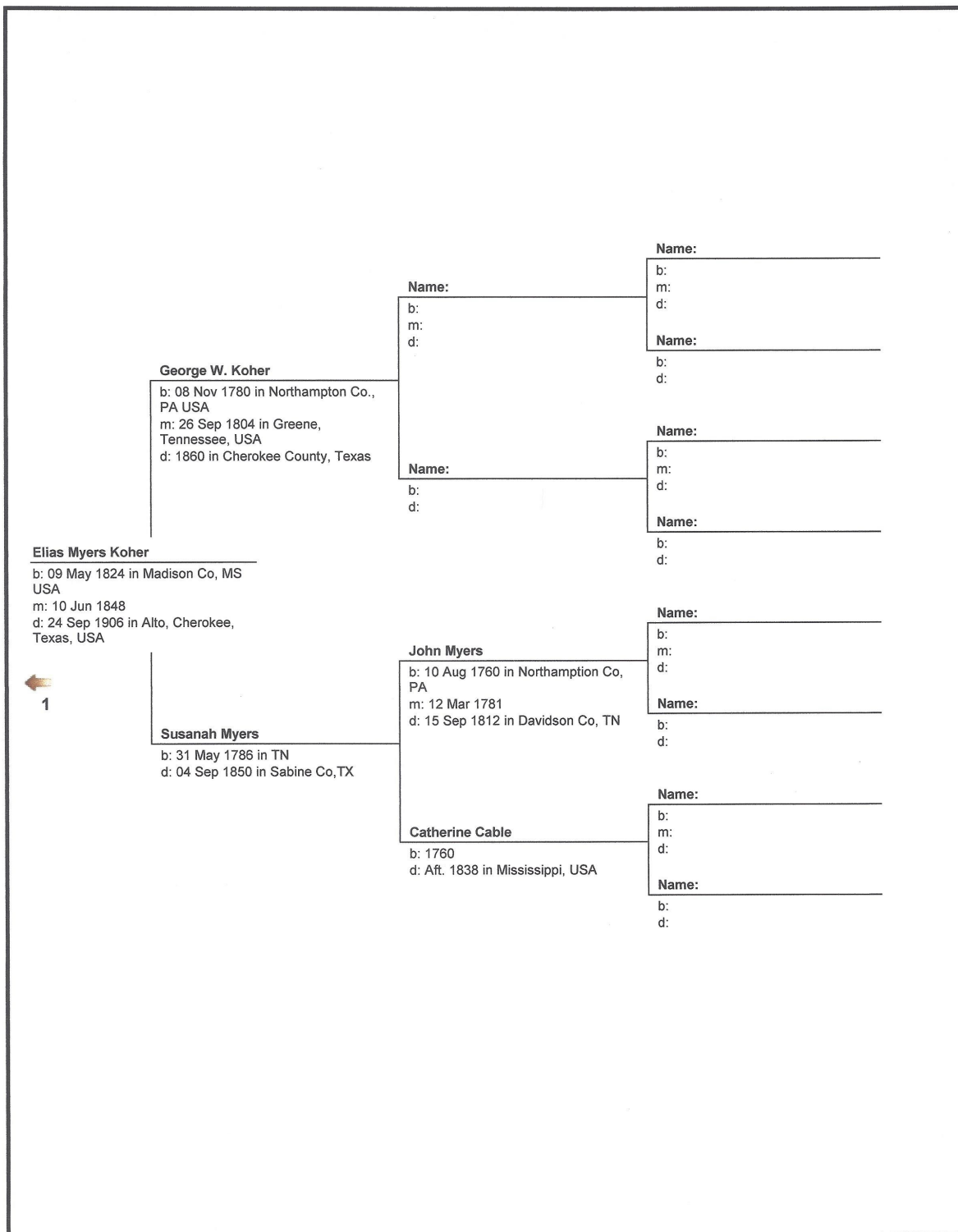


Pedigree Chart for Guynell Watters

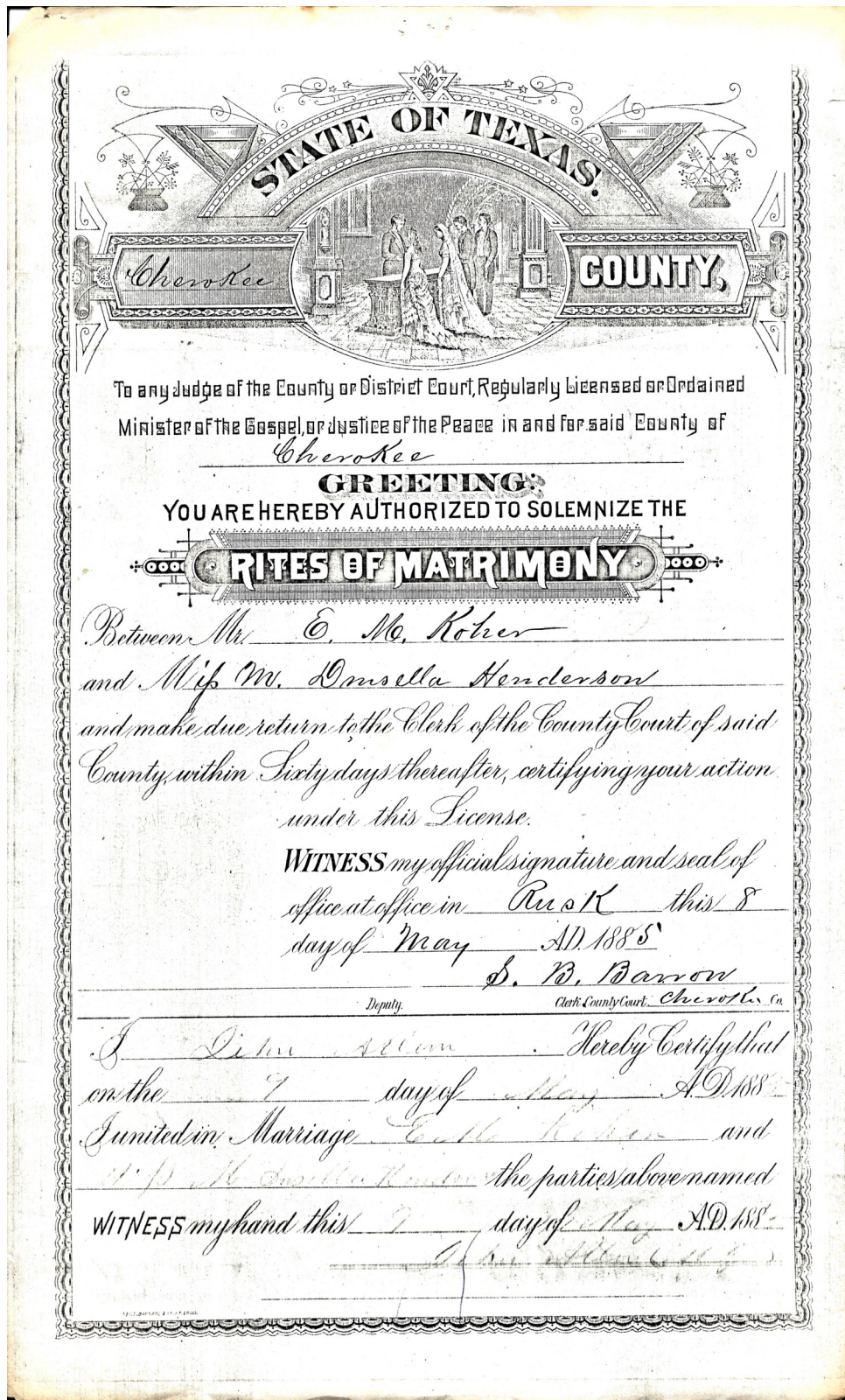
